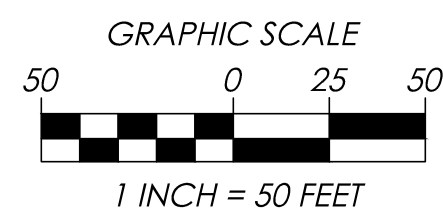
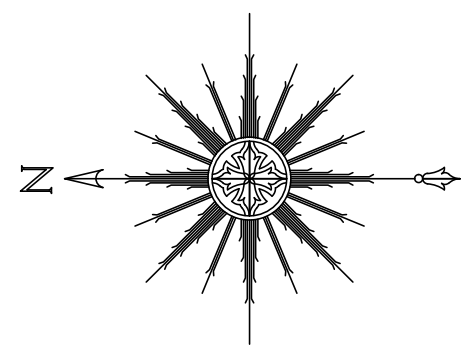


Plat of Lot Split & Assembly

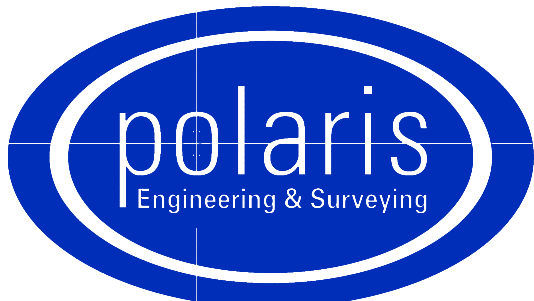
