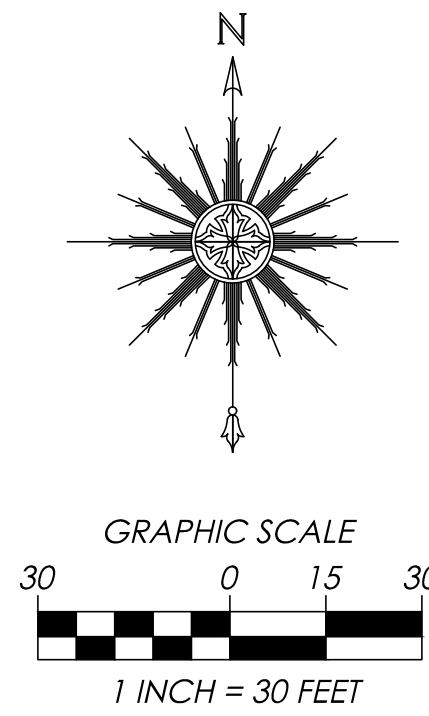


Plat of Lot Split

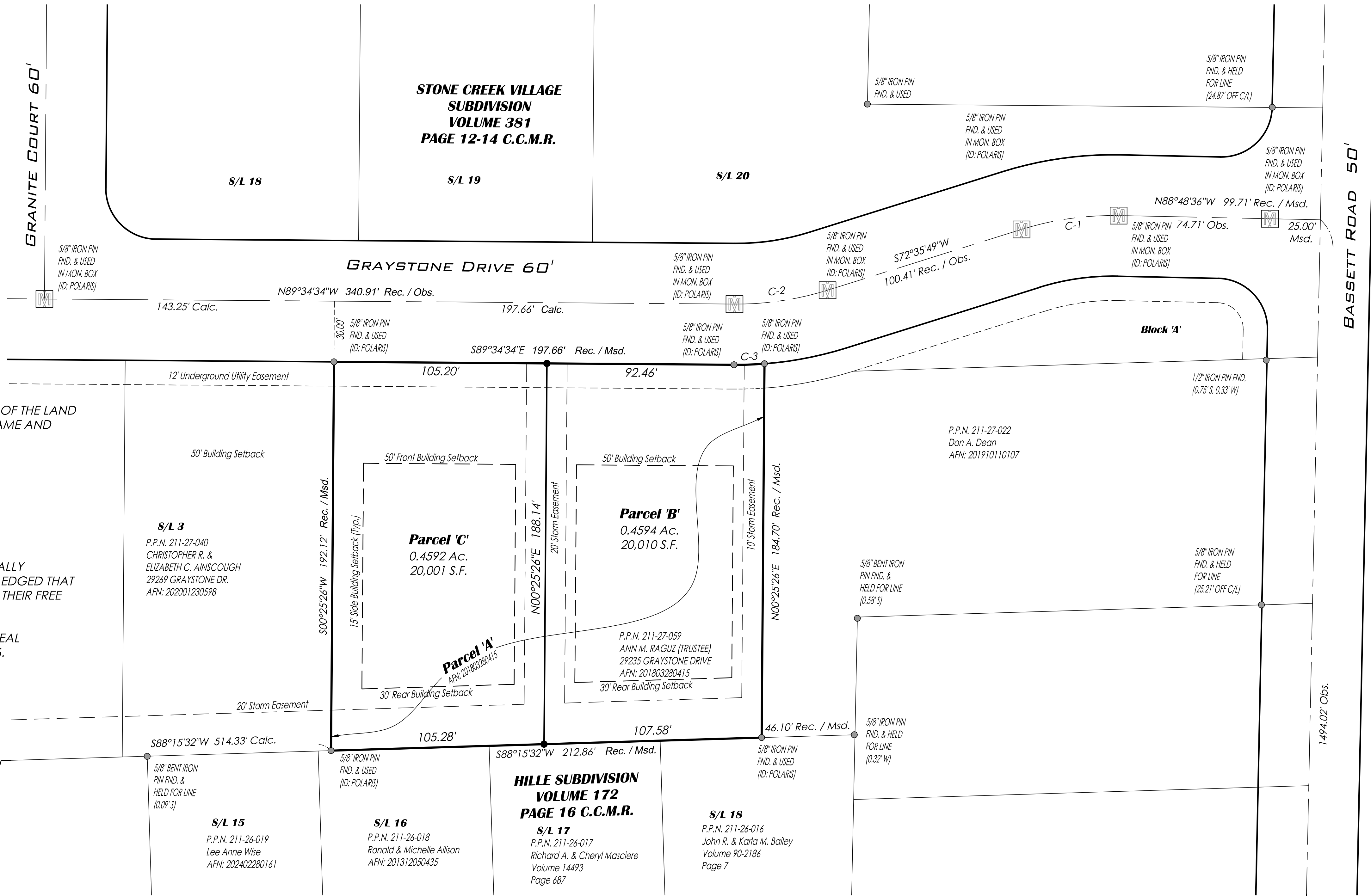

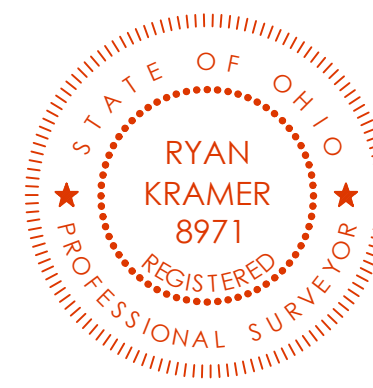
